

Town of Hayward Ordinance #17  
As Amended March 21, 2006,  
And as amended September 12, 2017

“ORDINANCE SETTING CLOSING TIME FOR TOWN PARKS AND PUBLIC ACCESSES  
WITHIN THE TOWN OF HAYWARD AND REGULATING PARKING OF VEHICLES AND  
TRAILERS IN PARKS AND PUBLIC ACCESSES”

**AUTHORITY**

The Town Board of the Town of Hayward, Sawyer County, Wisconsin, has the specific authority to adopt this ordinance under the provisions of Sections 60.22 and 61.34, Wis. Stats.

The Town of Hayward amends Ordinance #17 by repealing the old ordinance and reenacting and amending Ordinance #17 as follows:

SECTION 1 - Applicability

This ordinance shall apply to all Town parks and public accesses on all lakes within the boundaries of the Town of Hayward, except this ordinance shall not apply to the lake access on Osprey Lake and the lake access on Indian Lake Road, both of which are located within the bounds of the Lac Courte Oreilles Ojibwa Reservation.

SECTION 2 - Closing

The Town parks and public accesses shall be closed for any activities other than those defined below between the hours of 10:00 P.M. and 5:00AM. every day during the year. No person shall be in a Town park during the hours it is closed. Overnight occupancy of the Town of Hayward Recreational Forest will only be allowed with a valid camping permit.

SECTION 3 -Parking of Boat Trailers and Motor Vehicles

The parking of boat trailers and the access for boat launching or recovery, shall be permitted at the times when the boat landings and parks are closed, subject to the following: No person shall park a motor vehicle, snowmobile, ATV, or other trailer on the boat landing or public access overnight. It is the intent of the Town in enacting this ordinance that a boat may be recovered in the event that people are fishing after the hours that the park closes. In such a case, the motor vehicle, boat and trailer shall be removed as soon as possible after the boat is recovered from the lake or river.

SECTION 4 - Posting

This ordinance shall be posted by the Town at all Town parks and public accesses within the Town.

SECTION 5 - Penalties

Whosoever is found guilty of violating this ordinance, shall forfeit the sum of \$25.00, together with court costs and the costs of prosecution for the first violation, and the sum of \$50.00, together with court costs and the costs of prosecution for the second violation within one (1) year.

SECTION 6 - Severability

If any provision of this ordinance or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this ordinance that can be given effect without the invalid provision of application, and to this end, the provisions of this ordinance are severable.

SECTION 7 - Effective Date

This ordinance shall take effect upon its passage and publication as provided by law.

SECTION 8 - Repeal and Enactment

The Town Board, in enacting this ordinance, hereby repeals Ordinance #17 which was originally enacted on May 7, 1985 inclusive of an Amendment adopted 21st day, of March, 2006.
